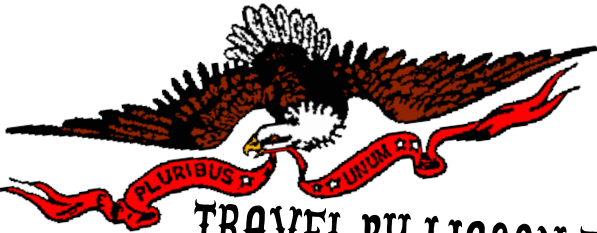

## REGISTRATION

1. Registration will be limited to 120 wagon passengers. Registration will close when the 120th wagon passenger registration is received.
2. Acceptance will be on first come, first serve basis.
3. To register for wagon train, send completed Registration blank with full payment of fees to the registrar.
4. Any registration over 120 will be placed on a Waiting list in chronological order. Those placed on the waiting list will be notified by the registrar.
5. Final In-Camp Registration will take place on **Sunday**, June 24th from 2-5 pm., at the Fort Seward Park in Jamestown, ND.
6. Orientation will take place on **Sunday**, June 24th At approximately 8:00 pm., at the Fort Seward Park. Activities will be designed to get acquainted, make staff introductions, discuss trail rider guidelines and answer your questions. Please attend this meeting.
7. On Monday, June 25th, we will rise, eat, pack and Move out on the trail.
8. Fort Seward Park is located on the northwest corner Of the city. Take Highway 281 through Jamestown (north). The park is on the crest of the hill overlooking the city. Its address is 1100 5th Street Northwest (look for signs).
